COME NOW, Robert Wayne Johnson to amend the VERIFIED MOTION TO MODIFY CHILD SUPPORT filed on March 8, 2010, for the purposes of adding to and clarifying the proposed verified modification of the original child support order, laying the following foundation:

- 1. The original order to pay \$438.80 per month is still in effect.
- 2. The hearing of January 13, 2010, established the following as per "proposed" ORDER, Item 2, January 13, 2010, Nunc Pro Tunc: "A voluntary change in care occurred in 2005. The Court will, therefore, retroactively modify child support to January 2005. Child support will be calculated based upon a worksheet B calculation for the years 2005-2007. Commencing 2008, the child resided with Mother and child support shall be calculated based on worksheet A."
- 3. Worksheet A, showing "child living with Father," should have been used to calculate child support for July 2005 through December 2007, while the child resided with me through the voluntary change in care. I freely waived my right to receive child support during that 30 month period, as would have been due me with an equitable contribution from Ms. Dolbow for my son's physical care.

4. I also waived my right to share an extraordinary educational expense when my son attended the Sylvan Learning Center.

- 5. In consideration of cash received from the unauthorized sale of the ATVs, the remaining child support in arrears for Year 2008 equaled \$900.
- 6. I withheld all child support payments in protest beginning October 10, 2008, when Ms. Jonica Brunner of the El Paso County Child Support Enforcement Unit told me I owed \$16,000 in back child support, and until the present.
- 7. I have continuously paid \$385 per month for my son's healthcare insurance.

Wherefore, the foundation being laid, using the worksheets exhibited in the VERIFIED MOTION TO MODIFY CHILD SUPPORT the following is the correct amount of child support withheld in protest:

- 1. \$900 from 2008.
- 2. \$3,949.20 for January through September 2009 at \$438.80 per month and \$2,873.16 for October through December 2009 at \$957.72 per month for a total due in 2009 of \$6,822.36.
- 3. \$4,070.28 for January, February, and March 2010 at \$1,356.76 per month.

The total amount of child support withheld in protest equals \$10,892.64. This compares to \$16,409.80 credited to the Family Support Registry in its report as of February 17, 2010.

I respectfully request that this Court enter an Order modifying my child support obligation as described above and to order El Paso County Child Support Enforcement Unit to issue a letter of compliance to the Department of Motor Vehicles to reinstate my driver's license; to return the difference of \$5,517.16; to remove any liens against real and personal property; to remove my name from the Family Support Registry and any and all similar databases; and to correct any and all negative information reported to consumer credit reporting agencies. For all corrected information, El Paso County Child Support Enforcement Unit shall issue an explanation of responsibility for the events leading up to said reports of derogatory information and provide proof thereof.
