Any written complaints or allegations of mishandling that have been raised against Policy Studies Inc. for the last three years using any of its trade names, i.e. COLORADO CHILD SUPPORT SERVICES, PRIVATIZATION PARTNERSHIPS, INC., PSIBER TECHNOLOGIES INC., CHILD SUPPORT SERVICES OF COLORADO, TELLER COUNTY CHILD SUPPORT ENFORCEMENT UNIT, EL PASO COUNTY CHILD SUPPORT ENFORCEMENT UNIT, PSI INTERNATIONAL PEACE AND JUSTICE CENTER, PSI HEALTH, CHILD HEALTH ADVOCATES, and PSI ARISTA.
5. The contract related to the design and start up of the CDHS Website.
6. The design and implementation documents for the CDHS website submitted prior to going online and its Year 2000 compliance assurance document.

If these records are not in your custody or control, please notify me accordingly and state in detail to the best of your knowledge the reason for the absence of the records, their location, CDHS and what person or persons has custody or control of the records, as required by SS24-72-203(2), C.R.S.

If you deny access to any of the above public records, please provide a written statement of the grounds for the denial, citing the law or regulation under which access is denied, as required by SS24-72-204(4).
